
Message from our CEO

Monitoring mechanism

We will ensure that our efforts are tracked through a monitoring mechanism to enable us to continuously improve our CSR program. The monitoring mechanism would entail the following:

- All our CSR initiatives will be monitored by a separate CSR monitoring team, appointed by the CSR committee.
- The monitoring mechanism will record the feedback received from stakeholders during field visits.
- The monitoring mechanism will cover both project related performance indicators and financial reviews of CSR expenditure.
- The key performance indicators related to project outcomes, financial outflows, and impact created by our CSR projects will be monitored on a bi-annual basis. If deemed necessary by CSR committee, we will carry out impact assessment studies by third parties.

The CSR Committee that we have formulated is responsible for the following:

- Development and periodic review of the CSR Policy as per the CSR Rules

- Assigning responsibilities to selected teams for implementation / facilitation / monitoring of CSR initiatives
- Overseeing and facilitating deliberation on the social and environmental consequences of decisions made by the Board

 Effectively factoring the interests of stakeholders such as: customers, employees, suppliers, business partners, local communities and other organisations in the decisions of the Board

Guidelines for implementation of our CSR Projects

The CSR committee will assign responsibilities to selected teams in DTL for implementation / facilitation / monitoring of CSR initiatives in one or more of the three CSR themes identified in this policy. The selected teams will design their CSR initiatives based on the following broad guidelines, with the flexibility to customize the project designs in accordance with stakeholder needs and local conditions.

Equip

Providing access to healthcare and safe drinking water

Project HARAPPA

Our objective of creating Project "Harappa" is to empower the rural and vulnerable communities located around our operations by providing access to healthcare, and safe water. We will facilitate the distribution of subsidized medicine for those who require it, and will also facilitate the installation of water purification units in identified villages.

Potential activities under Project Harappa

- Identifying and supporting a not-for-profit organization to facilitate distribution of subsidized medicine for those in need of healthcare services
- Identifying target populations / villages which require access to subsidized medicine
- Identifying target populations / villages where access to clean drinking water needs to be augmented
- Estimating the number and capacity of purification units required to meet drinking water requirements in selected villages / local communities
- Facilitating capacity building for the maintenance and operation of the purification units
- Awareness building of local communities / village residents on the importance of access to safe drinking water, and other health and sanitation related issues
- Monitoring of the water quality prior to and post installation of the units

Project STRIDES

The objective of creating Project "Strides" is to educate and empower, local communities. The target population would mainly consist of women, individuals from the under-served community and unemployed youth.

This would be achieved through the Industrial Skill Program by partnering with the Industrial Training Institute (ITI) Karnataka and possibly with United Kingdom Trade and Investment (UKTI) to develop the ITI into a center for excellence in aerospace.

Potential activities under Project Strides

- Engaging with 'Directorate of Employment & Training Karnataka' for supporting an ITI as a centre for excellence for skill development and vocational training
- Supporting the ITI with the provision of equipment for laboratories, volunteering of employees for training sessions at the ITI, and developing training modules
- In discussion with the ITI and other stakeholders, proposing targets for enrolment of women, students who belong to the rural community and students from under privileged backgrounds
- Identification of volunteers from the DTL to develop training modules for basic, advanced, and specific skill-set requirements
- Preparing an inventory along with estimates of the equipment and other practical lab instruments that would be provided to the ITI as a part of technology up-gradation initiatives and developing the ITI into a centre for excellence

Project CANVAS

The objective of creating Project "Canvas" is to enrich, preserve and protect national art and heritage through the following:

- (i) Preserving exhibits in museums and
- (ii) Maintenance of monuments of heritage importance

Potential activities under Project Canvas

Preserving exhibits in selected museum(s):

- Identifying a museum listed with the Archaeological Survey of India to extend support to
- Providing financial support for conservation treatment and preservation of museum exhibits
- Conducting capacity building for local artisans/students on preservation of museum exhibits
- Promoting awareness programmes on importance of the archaeological heritage to school children through programmes such as workshops and advertisements through electronic media

Maintenance of monuments / sites of importance with respect to national heritage:

- Participation in 'Adopt-a-Monument' scheme started by the state governments that has been launched as an instrument of public-private participation for maintenance of monuments
- Adoption of a monument /site with a view of restoration and maintenance for a period of 10 years in accordance with a conservation plan approved by the Dept. for Art and Culture

In carrying out both sets of activities, particular attention will be paid to the history of science and technology, to highlight not just the aesthetic and cultural heritage inherent in such monuments and museum exhibits, but also the scientific developments, evolution of technical knowhow and engineering capabilities that they represent.
